



## DAY CAMP CODE OF CONDUCT – SUMMER 2016

Aloha Beach Camp is committed to making the camp environment safe and fun for everyone. Accordingly, all campers and their parents are required to sign this “Day Camp Code of Conduct” to demonstrate their understanding of, and compliance with, Aloha Beach Camp’s behavior expectations from every child. No child will be admitted to camp without signing this Conduct Code, and moreover, failure to comply with its principles may result in immediate dismissal from camp. We urge you to review the following information closely with your child.

### ALOHA BEACH CAMP PARTICIPANTS ARE REQUIRED TO:

1. Be active listeners, cooperate, and follow directions given by camp staff, supervisors, guests, and lifeguards at all times.
2. Treat fellow campers, staff, supervisors, guests, lifeguards, public and private property, and the beach and beach environment with the utmost respect. We expect every camper to exercise goodwill towards others, our camp activities, and our natural surroundings. Courtesy and respect are requirements of the camp community.
3. Refrain from using rude, offensive, or generally bad language. Harsh verbal words, tone of voice, foul language or gestures will not be tolerated.
4. Keep their hands and bodies to themselves. If physical contact is made with another person, it must be a welcome gesture and appropriate. Unwelcome teasing, horseplay, pushing, kicking, hitting, fighting, bullying or harassment will not be tolerated.
5. Stay with their camp group, and their buddy, at all times. No child is permitted to leave the camp group without his or her counselor’s permission and direct supervision.
6. Refrain from bringing firearms, fireworks, or weapons of any kind to camp.
7. Refrain from bringing to camp or using any illegal drugs, tobacco, or intoxicants of any kind. Prescription drugs must be sent to camp with a note with clear instructions. The medicine must be in the original prescription container or labeled bottle.
8. Know and understand the general camp rules, regulations and guidelines as well as the rules, regulations and guidelines associated with their specific camp bus, van and group.

**NOTE:** It is not possible to anticipate every possible situation that may arise. In the absence of a particular situation or activity not listed above, COMMON SENSE AND COURTESY SHALL PREVAIL.

**CONSEQUENCES:** Our staff will immediately investigate all incidents. Should a child's behavior be deemed inappropriate, the camp staff will handle the situation with appropriate discipline practices. This includes “timeouts” from the group and notifying parent(s). Furthermore, any child who does not or cannot respect his or her fellow campers, our staff, the environment, and/or the entire camp community - and who does not respond to our intervention - will be dismissed from Aloha Beach Camp immediately and permanently. There will be no refunds in the event of a dismissal.
